Terms & Condition for Granting Scholarship

- (1). Those who have secured at least 90% marks in the 9th board examination can apply for the scholarship test.
- (2). Selected candidate will have to furnish an affidavit on stamp paper that during the candidate's stay in the college, he will abide by the college rules and in case of obtaining less than 90% marks in the 11th annual board examination (first annual), his scholarship will be cancelled and he will have to pay the fee in full like other students in 12th class.
- (3). The scholarship will be limited to the expenses of accommodation, food, tuition fee only. The FBISE examination fee and other expenses will not be included in the scholarship.
